### **President's Message**

# The Darzi Report - Independent investigation of the NHS in England

The College welcomes the <u>publication of the Darzi report</u> this month, although it makes hard reading given the focus on the widespread failings and deficiencies in the NHS. There are, of course, several themes that all stem from relative lack of capital investment over a sustained period and failure to properly workforce plan.

The components presented by Government and the media, incorporating 'the NHS is broken', 'there is no money' and 'difficult choices have to be made', make it clear that solutions are likely to take some time. It is vital that this College fully engages with NHSE, Government and the similar processes taking place across the other 3 UK nations to shape any future fix.

Although pathology is scarcely mentioned in the report, pathology is vital in tackling the problems that Lord Darzi diagnoses – from cancer waiting lists, to managing diabetes and other long-term conditions, or supporting A&E services with vital diagnoses.

As a member of the Expert Reference Group, and with many submissions from pathology

organisations being submitted Colleagues and I will work harder to ensure pathology is not forgotten in the upcoming 10 year plan and other devolved nation plans.

### The 10 Year Plan for NHS England

This is a very important milestone, as it will define the direction of healthcare and linked funding for the foreseeable future. We expect publication in spring next year, Having met the plan's lead, Sally Warren, last week, I discussed how pathology could be included. It was made clear the report will provide a strategic framework for delivery, focusing on broad concepts and pathways, and it will not be able to include every specialty. But the need to influence the overall plan was emphasised.

So, the College intends to develop its own 10 year plan for pathology that demonstrates the value of pathology across healthcare themes, as well as outlining the immediate, medium and long term action that we think needs to be taken around workforce, capital spend, digitisation (another Darzi theme) and innovation, such as AI.

#### A new RCPath Workforce Census

The RCPath workforce census is getting a significant revamp to better reflect the unique needs of our 17 specialties. The current form doesn't capture the full breadth of data necessary for effective workforce planning.

The new census will include more detailed information on sub-specialty interests, less-than-full-time working, career intentions, and workload. Your input and completion of the new census will be vital in supporting our workforce data collection. Further updates on its development and launch to follow.

In order for pathology's voice to be heard, it is vital that the College can collect and use data about pathology and pathologists as evidence for workforce planning and government/NHS plans. Please ensure you answer any calls for input. Our future services and professional wellbeing depend upon it.

#### **RCPath Celtic Nations Summit**

We hosted our <u>inaugural Celtic Nations Summit</u> in August which brought together the Chief Scientific advisors for the 3 devolved nations, regional council members and other key College representatives. It was a great opportunity to deepen our understanding of the particular ways the health services are set up and operate, to identify shared problems and look for shared solutions.

Issues discussed included: workforce and training, IT, digital and AI and strategies for key specialties and pandemic preparedness.

We will be publishing a report of the summit later in the year.

The College is committed to strengthening relationships across all 3 devolved nations and regional council members for Northern Ireland, Scotland and Wales represent their respective nations and provide professional leadership.

#### **Northern Ireland**

The College has launched its <u>priorities for Northern Ireland</u>, drawn up by the College Northern Ireland Regional Council, for the restored executive at Stormont. The priorities document has been sent to ministers and Members of the Legislative Assembly (MLAs). The College priorities for the executive focus on investing in workforce for patients, IT and infrastructure for better patient care, staff wellbeing, learning from the pandemic.

It was a pleasure to spend a few days in **Belfast** recently. Meetings with the deputy Chief Medical Officer, Chief Scientific officer and other pathology leads allowed for welcomed discussion on the new "Blueprint" for pathology. A great symposium followed and then some Q&A time with trainees. It is clear that despite the challenges faced, pathology in Northern Ireland has managed to emerge with a bold organised plan that incorporates collaborative working, digitisation and LIMS alignment, and workforce planning ideas, although the latter remains a huge concern.

I look forward to visiting Cardiff, Edinburgh and Glasgow next month.

# Medical examiner system moves to a statutory service

As the lead medical royal college for medical examiners, we were pleased to <u>welcome the move of the medical examiner system</u> to a statutory footing for England and Wales.

From 9 September 2024, all deaths across all health settings that are not investigated by a coroner will be reviewed by NHS medical examiners.

The College has long campaigned for the introduction of medical examiners and worked closely with key stakeholders for many years to implement this important patient safety initiative. Since the roll out of the non-statutory system in 2019, the College has trained over 3,000 medical examiners and officers.

# College response to the independent review of forensic pathology at the Hillsborough disaster

Glenn Taylor's report sets out in detail the absence of information, understanding and empathy experienced by the families in the face of the Hillsborough tragedy.

As a College, we will carefully consider the recommendations in the report and focus on those areas where we can support change.

We welcome recognition from the Secretary of State for the Home Department, Yvette Cooper, that there needs to be resilience in pathology services, and a review of the structure of pathology in England and Wales. The recommended increase in in the number of forensic pathology trainees to eight is welcome, and is the commitment to keep the situation kept under review.

The College believes that any such review must encompass the coroner service.

### Parliamentary engagement

 We've had an article published in Science in Parliament, the journal of the <u>Parliamentary</u> <u>and Scientific Committee</u> - 'Embracing AI to <u>support early diagnosis: Royal Colleges</u> <u>publish shared action plan</u>'. Science in Parliament is a key publication to be featured in as it provides a liaison between parliamentarians, scientific bodies, sciencebased industry and the academic world.

### Autopsy webinar series - Sickle cell disease

### **Autopsy webinar series - Post Mortem CT**

During this session we will discuss how the CTPM service in Leicester operates, the triaging of cases for CTPM (plain or angiography), the importance of our consultant radiologist colleagues in reporting the images and how this guides us with either providing a cause of death or by

refining our subsequent investigations in determining the cause of death e.g. limited or targeted invasive post mortem examination +/- histology, microbiology/virology.

### **Autopsy webinar series – The Human Tissue Authority**

**27 November 2024**

The Human Tissue Authority (HTA) regulates organisations that remove, store and use tissue for post-mortem examination, medical treatment, research, teaching and display in public. Making sure human tissue, cells and organs are handled with dignity, used with consent and stored safely, is at the heart of what we do.

This talk will explore the role of the HTA in regulating the Post Mortem sector within England, Wales and Northern Ireland. The discussion will cover a brief history, the Human Tissue Act 2004 legislation, the HTA's regulatory framework and the regulatory tools and activities we have developed in this diverse sector.

We regulate in an environment of ongoing change, technical advances and challenges. We will share how the HTA reflects on lessons learned to achieve our aim, of being an excellent, modern and accountable regulator dealing proportionately with the sector, whilst supporting licensed establishments to achieve the set standards.

### From snails to sperm whales: PMs across 10 orders of magnitude

Dr Simon Spiro is the veterinary pathologist for the Zoological Society of London, where he is responsible for the diagnostic pathology of the society's 23,000 animals of 800 species. He is also the pathologist for the Cetacean Strandings Investigation Programme (CSIP) which investigates dead whales, dolphins, sharks, turtles, and seals in English and Welsh waters. In this talk he will cover the what, where, how and why of wildlife pathology, covering everything from the practicalities of performing post mortem examinations on everything from tiny invertebrates up to massive whales, to the science and conservation work that results. This talk will cover topics such as cholesterol mediated diseases in meerkats, bacterial diseases in bats and orthopaedic disease in whales, all told with the aid of pictures, video and digital microscopy.

### An update on feline soft tissue sarcomas; where are we now, and where do we go next?

The past, the present and hopefully the future of prognosticating feline soft tissue sarcomas; this webinar aims to give an overview of where we currently are regarding the histological grading of feline soft tissue sarcomas, with some insight into the origins via grading STS in humans and canine, and the development of the proposed grading system in cats. It will look at some of the challenges, including nomenclature, subtyping, the complication of feline

injection site sarcomas, and the subjectivity of some aspects. It will also look at where we would like to go in the future....

The College is the <u>lead medical royal college for medical examiners</u> and provides training for any doctor wishing to work as a medical examiner. Participants will need to complete mandatory 26 e-learning modules and attend an entire face-to-face training day to receive a certificate of completion. The day includes short presentations, small group discussions of case scenarios and the opportunity to share experience. Medical Examiner Training is open only to medically qualified individuals who work in England and Wales.

### Medical examiner officer training

The College also leads on the training of <u>medical examiner officers</u> (MEOs).

MEOs work closely with medical examiners and undertake tasks such as coordinating the completion of death certificates and referrals to the coroner, and speaking to clinicians and bereaved families.

MEOs may come from a wide range of backgrounds. For example, nurses, healthcare scientists or bereavement officers although this list is not exhaustive. More information, including a <u>model job description</u>, is on the <u>College website</u>.

The face-to-face training day is the second part of MEO training. Everyone attending the course must have completed the 26 mandatory core e-learning modules before the date of the course to get the most out of the training day.
